## MLC Governing Council Meeting Minutes March 12, 2019

- 1. Steve called the meeting to order at 6:36 p.m.
- 2. Pastor Doug led the opening devotion and prayer. Spoke of the temptations from last week's text. Luke 4
- 3. Approval of minutes from 2-12-2019: Dave moved to accept; Seconded: Cassandra; minutes approved
- 4. Approval of Reports
  - a. 2019 Treasurer (Ellen absent): report has been filed...no questions, table questions for next month
  - b. 2019 Building and Grounds (Carlo absent): No report; Dave H. report:

  - d. 2019 President (Steve) computer support: Operating System on computer in sanctuary does not support Internet. Rosemary says that the computer in office is working okay; Steve has a friend that can help us out with hardware...we will have to look at the computers that we have and do an inventory of operating systems on each
  - e. Pastor Doug Report.

- i. Dreams and Ideas discussion; Pastor explained the steps for this process better. He has outlined 6 steps; discussed these with Pastor Sara. She will come to the 3/24 meeting; Kennedy middle school will also be here to give input. We will need a record keeper for this meeting (Lee will not be here on this Sunday).
